General Product Description/Intended Purpose

Stülpa® and TubeGaze are single-use, non-sterile tubular bandages used by instructed lay-user and healthcare professionals on intact skin as inner lining to protect skin from zinc paste bandages, support cast, adhesive and cohesive bandages; or used as outer lining to protect primary wound dressings / compression bandages or for fixation of dressings in combination with other fixation aids.

Stülpa® and TubeGaze are considered a medical device in Class I.

Application/Indication

The densely-knitted, tubular construction serves to protect skin from zinc paste bandages, support cast, adhesive and cohesive bandages. Furthermore, Stülpa® and TubeGaze can be used for dressing protection and fixation of dressings with other fixing aids.
